

1. In order to be eligible to attend Summer Bronco Club, a child must be toilet trained and have completed PreK-5 grades.
2. I/We understand and agree to pay the following tuition and fees in order for my child to attend BC:
  - a. **CAMP COST (Tuition):** Camp tuition must be paid online or at The Mustang Education Resource Center, 909 S. Mustang Rd. **Total camp cost is due at time of enrollment.** PAYMENTS CANNOT BE MADE AT CAMP. Full camp tuition is due whether your child attends the entire week or not.
  - b. **LATE PICK UP FEE:** If a child is not picked up by closing (6:00pm for summer camps) a fee of \$10 will be assessed for each five (5) minute increment a parent is late (e.g. 6:01pm arrival - \$10 fee, 6:06pm arrival - \$20 fee). If a child has not been picked up within 30 minutes of closing and attempts to contact parents and emergency contacts have been made, the police and the Department of Human Services may be called. BC reserves the right to suspend and/or terminate enrollment for recurrent late pick-up. When a parent is contacted for ANY reason during camp hours, the late pick up fee will be assessed beginning one hour after the time of notification.
  - c. **NON-SUFFICIENT FEE:** A fee of \$25 will be assessed for each returned check or non-sufficient funds notification. The amount of the returned check plus the \$25 fee must be paid by cash or money order. Upon the second occurrence, all future payments must be made with credit/debit card, money order, or cash.
3. I/We understand my child can be removed from the program as a result of an unpaid debt.
4. I/We understand **7 days advance notice is required to change camps or withdraw from the summer program.** Notice allows account adjustments to be made and additional fees to be avoided. If written notice is not given, parents are responsible for the full weeks camp tuition.
5. I/We understand and agree to the following refund policies:

Refunds can be requested until noon (12:00pm), one week (7 days) before camp starts; all but \$50 will be refunded. No refunds will be given after the refund deadline. **NO REFUNDS WILL BE GIVEN FOR DISMISSAL FROM THE PROGRAM FOR ANY REASON.**

6. I/We will make other arrangements for emergency closings, delays and early dismissals (e.g. snow days, facility problems). I/We understand pre-paid tuition for cancelled day(s) will be credited to my child's Bronco Club account.
7. When picking up my child from BC I will sign him/her out of the program. Identification may be requested at any time by Bronco Club staff.
8. I/We understand any personal belongings brought to BC are the responsibility of my child. I/We will not hold BC responsible for replacement or repair of any items that may be lost, stolen, or broken.
9. I/We understand that if my child continuously demonstrates inappropriate/unacceptable behavior I will be notified and my child may be removed, suspended for a period to be determined, or excluded permanently from Bronco Club. See handbook for additional details.
10. I/We will notify BC personnel in writing if there is a temporary health issue which may inhibit my child's typical daily routine (e.g. sprained ankle, injured collar bone, elbow - no running, climbing, getting over illness - no physical activity, etc.).
11. I/We acknowledge that my child will not attend Bronco Club if suffering from an infectious or communicable disease as identified by the Department of Health.
12. I/We understand divorced/separated parents are jointly and respectively liable for tuition to BC. It is not BC's concern who pays, only that tuition is paid. I/we agree to pay tuition on time regardless of agreements made between parents.
13. Hours of operation: 7:00am-6:00pm - Doors do not open before 7:00am.
14. I/We have read and agree to the policies and terms outlined in the Parent Handbook, which contains detailed information on Bronco Club policies and procedures and is available online at [Bronco Club Handbook](#)
15. I/We agree to provide legal custody documents if requested by Bronco Club.
16. I/We understand Bronco Club reserves the right to amend Terms and Conditions and the Parent Handbook.
17. By signing these Terms and Conditions I declare and confirm:
  - All information I have provided in this enrollment form is true and correct; and
  - I am a parent of the child and a person with parental responsibility in relation to the child referred to in the enrollment form; and
  - I agree for both my child and I to comply with Bronco Club policies and procedures; and
  - I have read, fully understand and agree to comply with the above Terms and Conditions, and the Parent Handbook.
